The Rocky River Regulators opened the 2010 shooting season on Sunday, March 21<sup>st</sup>. Rocky River was a little "soggy" and the weather forecasters predicted rain and snow, but at least the shooting area decking was above water and relatively dry. We had 22 hearty shooters, some were "rusty", and

some in mid-season form, and when the lead stopped flying our first match winner of 2010 was Deuce Stevens. Not only was Deuce FAST but he also shot a clean match. Other

shooters that distinguished themselves and had clean matches were J.J. Longley, Moe Gunns, Nine Finger Bob, and Goatlips.

If you are looking for Cowboy Action Shooting fun, remember that the DSC Rocky River Regulators shoot regularly the 3<sup>rd</sup> Sunday of the month (couple of exceptions, so check the Wolverine Rangers web site), so please plan to shoot at our next monthly match on Sunday, April 18, 2010.

If you're looking for something different, we have silhouette shooting that will test your skills and put a smile on your face. We have a Silhouette Match scheduled on Saturday, May 15, 2010 at 12 PM. Practice for the Silhouette Match will start at noon with the safety meeting at 12:45pm. The match should take about 2 hours. Any pistol caliber lever or single shot rifle is welcome as well as 22 rim fire rifles. There will be classes for all rifles and ages. Bring out your .22 rifle or your cowboy pistol caliber rifle and try your hand at a fun shooting experience. Remember, standard velocity and lead bullets ONLY, except .22 ammunition can be plated.

Look for the flier on <u>www.d-s-c.org</u> web site. Also this year the cowboys will be hosting three .22 rim fire matches and a Wild Bunch match. Watch the web site for details down the trail. See you on the range.

#### **HURON RIVER RAIDERS**


# Don't miss this chance to come shoot with the Regulators and keep yer gold in yer pocket!

### HIDDEN VALLEY COWBOYS

Fellow Wolverine Rangers:

The Wolverine Ranger free shoot for this year is at Hidden Valley Cowboys in Sturgis on Sunday, July 11, 2010 (See map on Wolverine Rangers web page under Clubs). Registration will start at 0900 hours and side shoots start at 0930 hours, the mandatory safety meeting starts at 1045 hours. Lunch is after the match.

This match will be designed by Three Gun Cole. Many of you may remember Three Gun Cole designed our "Fast & Furious" match last year and we all had a blast!

All SASS rules apply along with the following club rules: eve and hearing protection is

eye and hearing protection is mandatory for everyone in Hidden Valley whenever there is any shooting being done. Any accidental o r

premature dis-

charge of any firearm resulting in a round leaving the rage will result in stage disqualification. A second stage disqualification on the same day shall result in a match disqualification. The maximum size shot for any shotgun target is a  $\# 7 \frac{1}{2}$ . Lead shot or smaller, no magnum or high-velocity loads allowed

Information for anyone who might be interested in coming the night before the match. There are three motels at I 80/90 and Mi 66, Super 8, Best Western and Hampton Inn (with over 200 rooms combined) all three are within 10 miles of the range and all three allow guns in their rooms.

# ★ Shooting Tips ★

#### HOWDY AGAIN,

I sure hope that you single shot shooters are gettin' some useful information out of these articles. Nuthin' would please me more! Now bear with me on this installment because I'm gonna teach you how to roll your own MATCH QUALITY black powder cartridges.

If you go black, you'll quickly find out that the different grades of powder give different results just like different brands of smokeless. Start with Goex FF or Goex etg. Powder. FFF grade powder is generally for small caliber cartridges up through 38-55. Swiss powder is excellent but more expensive. F grade powder burns the slowest and FFF burns the fastest.

Before we start to reload, I'll tell you how to find out where the rifling starts in your rifle. This is important because this determines the overall case length for EACH black powder bullet/load combination. Just trust me. You need to know this. Take an unprimed cartridge case and full length resize it. Run it up into your expander/belling die. Seat the bullet in the case mouth. Take the seater die and UNSCREW the seater plug about half way. Now run the cartridge up into the seater die so the bullet is only seated in the case about 1/4 inch. Place your rifle in a gun cradle, open the action, and very gently chamber the cartridge until it stops. Don't force it. The bullet has just touched the beginning of the rifling. Note how much the cartridge sticks out of the chamber. Screw the expander plug down into the die a little, run the cartridge up into the die again to seat the bullet a little deeper, and gently chamber the round again. Repeat this process until the cartridge enters the chamber fully and JUST BARELY touches the rifling at the same time. This is now the overall cartridge length for this bullet style ONLY. You may have a couple of grease grooves exposed, maybe not, depending on the bullet style. Finding this out will usually allow you to get a few more grains of powder in the case. Remember, we want the case FULL of powder. HUNTING loads should have no grease grooves exposed...you don't want dirt getting in that bullet grease and then going down the barrel! Each style of bullet will engage the rifling in a different place so you must repeat this process for each different bullet style you try. Record the overall length. NOW LISTEN UP! Some rifles like to have the bullet seated up to .060 in back of the rifling, some like the bullet to just touch the rifling, and some rifles like to have the bullet firmly seated into the rifling .030 or so to get MAXIMUM accuracy. It's up to you to find out. CAUTION: if you seat the bullet out too far the cartridge will be hard or impossible to chamber. On the other hand, if the bullet is seated too far away from the rifling and has to "jump" before it engages the rifling, accuracy may suffer.

You should start by either full length sizing or neck sizing your cases. I prefer neck sizing because it "works" the brass less. The only catch with neck sizing is that you have to dedicate this bunch of brass to this rifle ONLY since it might not fit the chamber of another rifle of the same caliber. Now is the time to MEASURE THE CASE LENGTH. Cases grow when sized. If you don't check the length, the cases will "grow " past the length of the chamber. If this occurs, the bullet gets deformed and pressure increases because the case mouth is bent INWARD past the end of the chamber and digs into the bullet. This is definitely not good for accuracy! Prime the case with the primer of your choice. Run the case up into your expander die. Generally, the expander plug diameter should be about .002 LESS than the bullet diameter. Example: bullet diameter .458, expander plug diameter .456. Set the die to bell the case mouth SLIGHTLY so that the bullet will enter the case only about 1/16<sup>th</sup> of an inch. Belling the case mouth more than this is not necessary because excessive belling work hardens the case mouth and you start to get split case mouths after only a few reloadings.

Now it's time to charge the case. You can get in a couple of extra grains of powder if you use a drop tube. You can make one out of an old aluminum arrow by flaring one end and gluing a small \$1.00 wal-mart plastic funnel on the end. If you don't want to go to the trouble of making a drop tube, gently tap the charged case lightly on the reloading bench about 20 times to settle the powder. At the MINIMUM, the powder should come up to where the base of the seated bullet will be. You can add another couple of grains of powder to get up to 1/8 inch of compression. More than that isn't generally necessary. NEVER LEAVE AN AIR SPACE BETWEEN THE SEATEDBULLET AND THE POWDER. Now you can put a .030 or .060 poly or card wad in the case mouth and push it squarely onto the powder with a pencil. Take the bullet of your choice, place it STRAIGHT UP in the case mouth, and run it up into the seating die which is now adjusted for this bullet style. DO NOT CRIMP THE CASE! If any lead is shaved off the bullet, just bell the case mouth a little more. Most of the big bullets don't have a crimping groove anyway. Adjust the die to take the bell out of the case mouth ONLY. The case neck tension alone should firmly hold the bullet in the case.

All you have to do now is shoot your brand spanking new match grade ammo. After each shot you can either blow 4 or 5 slow breaths down the bore using a blow tube or run a DAMP [NOT WET!] patch down the bore between shots. After using a blow tube for 15 years I have switched over to the damp patch between shots. I will give you several reasons why I did this. First, it's way quicker and you don't hyperventilate between shots. Second, the 10% of the fouling that is left in the bore after wiping is WAY more uniform than ALL the fouling that is left in the bore with a blow tube. Which ever way you use, keep the blow tube or the wiping rod CLEAN! You don't need to be introducing sand and grit into the bore of your prize rifle. Owners of trap door Springfield rifles must use a blow tube because the action will not permit a cleaning rod to be used from the breech end. Stay tuned and hold center.
