The first stage was a challenge as the shooters were faced with the "Ducks fly at night" scenario of multiple magazine changes and the "flying V" of shotgun targets. It did not take long for the morning sun to warm up the range and the competition to get hot and furious. When the scores were tabulated the overall winner in the SASS Modern class was Coyote Claxton. Coyote edged out Camptown by 4 seconds. Shooting in the other SASS recognized classes using "big" bullets; Leadfoot Luke won the SASS Men's Traditional division. Hey Sugar was the SASS Women's Modern winner and Dodge City Dick won the "Open" division. Shooting Clean matches were DSC's Coyote Claxton and Dodge City Dick.
