★ Captain's Corner ★

Howdy pards,

Lefty Dutchman is one of our regular Canadian shooters who comes to Range War just about every year. Lefty came up to me at the end of the Banquet and Awards Presentation last year at Range War and suggested that I should come to Canada and shoot one of their matches. We have a significant number of Canadian shooters who participate in Range War every year and I agreed that it was time I went to shoot with the Canadians. I attended the SASS Central Canadian Regional over the weekend of July 14th and 15th.

Obviously my initial hesitation and I am sure that of most shooters from the U.S., is the concern about taking guns and ammo across the border into Canada. I have to say that actually the process was very easy. Lefty put me in contact with Ms. Karen Amon, the Chief Firearms Officer of the Chief Firearms Office of Toronto. She was extremely helpful and she was also very nice. She really tried to make the process easy and it was. She sent me copies of all of the required documentation and I had no problems of any kind.

As part of the registration process for the match, Lady Smith sent me the confirmation for my registration as well as an information sheet with important information about bringing firearms into Canada from the U.S. One thing that I did not do was to click on the link to review the information about storing, transporting and displaying firearms in Canada. (See the accompanying Information Letter entitled "Bringing Firearms to Canada from the U.S.) I followed the U.S. laws and had my 4 firearms in locked cases but I did not have trigger locks on the handguns which I later found out is a requirement. (See the attached screen shot from the Royal Mounted

Police about Storing, Transporting and Displaying Firearms.) Fortunately for me, the customs agent who checked my Rugers did not raise an issue about the lack of trigger guards and I passed through customs with no issues. Frankly, all of the customs people were very nice and the process of making it through customs was very easy. I talked to one of the customs agents about Cowboy Action Shooting and she was very interested hearing about it.

There are a couple of rules that I had a hard time understanding when I got to the Range. It turns out that you are supposed to take your hand guns in the locked case to a table near one of the stages and unlock the case and put the guns in your holsters there. You are not supposed to do that standing outside of your car or truck. Needless to say, I put my guns in my holsters while I was unloading my truck and was nicely informed by Crow, the Match Director, that next time I need to take the guns in the locked case to one of the safe tables at one of the stages. After I was done shooting the match, I took my handgun case to one of the safe tables and took off my handguns there and put them in my case and locked it. Not a big deal and even Crow said that some of the rules do not make a lot of sense.

I did not get to shoot the side matches due to my late arrival on side match day. It was a 270 mile drive and it was a little slow near Toronto. We shot ten stages on 4 bays for the match. One large bay had two stages. They actually had 4 bays that were being used and each set of targets was shot twice. This means that they only had 5 sets of targets. For the second go round for each set of targets there would be a new stage written with a different shooting sequence. Actually, that was pretty efficient and it saved a lot of walking.

One of the strange rules that they have in the Province of Ontario is that all targets must be "shrouded". This means that the targets have to be covered so as to prevent a ricochet from deflecting from the target and killing someone in the surrounding community. Frankly, I would like to see the supporting evidence for that rule. The way that they handled this was to have a roof over a series of targets or at least fun, shoot clean and stay safe. a wooded covering over all of the targets. This was not a big problem and the Club handled this well

One of the other rules is that all targets, including shot gun targets, must be at least 10 meters from the shooting line. This means that all targets had to be at a minimum of about 33 feet away. Bring your heavier shot gun loads. I did pretty well with Winchester extra-lite but I did hit a couple of targets head on and they did not go down the first time. One of the benefits of the targets being farther away is that it forced me to aim and to use my front sight. Obviously that is a good habit to get into.

All in all I had a very good time and I will be going back. Barrie, Ontario is a very nice town and all of the people were very nice. I really enjoyed the people on my posse. Hopefully I will be able to bring The Lady the next time

Bringing Firearms to Canada from the U.S.

- 1. Register for the match. Keep copies of the registration form and acceptance letter.
- 2. Make sure your passport is valid, or apply for one.
- 3. For instructions on completing the required forms, follow the instructions at http://www.losttarget.com/firearmcanada.html.
- 4. For information on storing, transporting and displaying firearms in Canada, go to http://www.rcmp-grc.gc.ca/cfp-pcaf/fs-fd/storage-entreposage-eng.htm.
- 5. Contact Karen Amon at the Chief Firearms Office 1-800-731-4000 x7549. She can answer any questions you may have. She will also be the person to issue the Authorization to Transport (ATT) for all the restricted firearms. Send all the forms to Karen requests via fax 1-705-330-4298 or email at karen.amon@opp.ca or as she directs.

These rules apply to individuals. There are different rules for businesses.


Storing Firearms Safely

Unload and lock your firearms!

Store the **ammunition** separately or lock it up. It can be stored in the same locked container as the firearms.

Non-restricted firearms

 Attach a secure locking device, such as a trigger lock or cable lock (or remove the bolt) so the firearms cannot be fired; or



· Lock the firearms in a cabinet, container or room that is difficult to break into.



Restricted and prohibited firearms

 Attach a secure locking device so the firearms cannot be fired and lock them in a cabinet, container or room that is difficult to break into; or





- Lock the firearms in a vault, safe or room that was built or modified specifically to store firearms safely.
- For automatic firearms, also remove the bolts or bolt carriers (if removable) and lock them in a separate room that is difficult to break into.

Transporting Firearms Safely

Non-restricted firearms

Non-restricted firearms must be unloaded during transportation.

Restricted and prohibited firearms

- · Unload the firearms; and
- · Attach secure locking devices to the firearms; and
- · Lock the firearms in a sturdy, non-transparent container; and
- Remove the bolts or bolt carriers from any automatic firearms (if removable).
- Obtain an Authorization to Transport (call 1-800-731-4000).

Leaving Any Class of Firearm in an Unattended Vehicle

- · Lock non-restricted firearms and locked containers carrying restricted or prohibited firearms in the trunk or in a similar lockable compartment.
- · If the vehicle does not have a trunk or lockable compartment, put firearms and firearm containers out of sight inside the vehicle and lock the vehicle.
- · If you are in a remote wilderness area and cannot lock your non-restricted firearms inside your vehicle, unload them and put them out of sight. Attach a secure locking device to the firearms unless they are needed for predator control.



Displaying Firearms Safely

Unload and lock your firearms!

Here are the rules for displaying firearms in your home: Ammunition cannot be displayed with, or accessible to, the firearms.

Non-restricted firearms

- · Attach secure locking devices to the firearms; or
- · Lock the firearms in a cabinet, container or room that is difficult to break into.



Restricted and prohibited firearms

- · Attach secure locking devices to the firearms; and
- · Securely attach them to something that cannot be moved.
- · For automatic firearms, also remove the bolts or bolt carriers (if removable) and lock them in a separate room that is difficult to break into.

Some rules may be different for firearms displayed away from home - for example, at a gun show. Contact the RCMP Canadian Firearms Program (CFP) for more information.

For more information, or to report a public safety concern, contact the CFP.

Remember

- · Don't forget to renew your firearms licence before it expires.
- · Contact the CFP within 30 days if your address changes.

The Great Train Robbery

As the train was making its way between Coopersville and Marne it was attacked by a group of desperados who had been laying in wait for the train to appear. A few shots were fired by the bandits, but the train did not slow down and managed to escape unscathed.



The bandits were undeterred. They all hopped into their four wheeled horses and made a hasty trip to the end of the line in Marne.

While the engine was uncoupled and being moved to the other end of the group of passenger cars for the return trip, the desperadoes once again attacked the train. There was nothing the passengers could do as there was no engine attached.

But wait. As it turns out the sheriff and a few deputies were also on the train. The lawmen disembarked from the train and a large gun battle took place. The fighting lasted for 15 to 20 minutes during which time many gun shots were fired by both the robbers and the lawmen. Fortunately, no one was seriously hurt during the battle. The robbers were heard to say things like "If it ain't dirty, it ain't fun" and "I have saddle sores tougher than you". Eventually the lawmen were able to chase off the wannabe thieves who once again mounted



their trusty four wheeled steeds.

On the return trip from Marne to Coopersville the train was again attacked by the robbers. This time the train was successfully stopped and the robbers boarded the train—two to

each car. They quickly went through the cars relieving the passengers of the valuables they had purchased prior to the train trip. All the cash and most of the jewelry were taken by the robbers. It was later found out that the cash consisted mostly of \$27.00 and \$143.00 bills. The jewelry was described by some of those who had been looted as being very valuable plastic necklaces, bracelets and rings. The total value of the stolen items is yet to be determined.

Unknown to the robbers, the sheriff and deputies were still on board and the robbers were hustled off the train. A short gun battle ensued Article submitted by Outrider Outlaw--one of and the robbers were captured and thrown into the nearby jail which strangely resembled a horse trailer.

But, unknown to the lawmen, they had failed to capture the gang's leader who quickly broke the gang out of jail. Thereafter, the robbers approached the train and returned much of the loot they had gathered and "high-fived" many of the younger passengers.

The lack of serious injury on either side was found to be the result of someone inadvertently loading all the revolvers with blanks.
